#### **Artist Guidelines**

This event is held in the Richfield Nature/Historic Park, a sensational wooded backdrop with many historic buildings including the renovated Messer/Mayer Grist Mill. This is the 16<sup>th</sup> year for this event.

#### **Artists Amenities:**

- Easy access for setup
- Sufficient space between booths
- Free coffee and pastries during setup
- Assistance in getting lunch (avoid line)

- Booth reliever (typically mid-day)
- Fliers for advertising
- Tour of historic buildings

#### **Guidelines and Requirements:**

#### Application Fees and Deadlines

- Booth Fee for applications received before or on April 1, 2024 -- \$60
- o Booth Fee for applications received from April 2, 2024 through June 1, 2024 -- \$70
- Jury Fee (nonrefundable): \$10 (Jury Fee is waived for previous exhibitors at this event)
- No applications will be accepted after June 1, 2024

#### • Booth Information:

- Artists supply their own booth/tent (10 ft x 10 ft), tables and chairs the fair goes on rain or shine
- Setup must be completed by 10 am and remain in place until 4 pm
  - When setting up, be sure to unload your booth and supplies. Then, immediately move your vehicle to the parking area before setting up. This will alleviate congestion and blocked vehicles.
  - At 4 pm, vehicles can be moved from the parking area to your booth. This must not be done prior to the 4 pm closing time.
- o If necessary, make sure you have the required insurance/license to sell your products

#### Art Work Requirements:

- o All work must be original, handcrafted and created by the artists themselves
- Kits, imports and mass-produced items will not be accepted
- o Items to be sold CANNOT include copyright or commercial designs (For example: sports and/or college logos, cartoon characters or logos, action-hero characters or logos, etc.)
- Any artist whose work is found to be inconsistent with submitted photos will be asked to leave the fair

#### General Information

- All of the above requirements will be strictly enforced
- FYI Sales Tax for Washington County is 5.5%
- Any artist under the age of 18 must be accompanied by an adult.
- No political activities are allowed as RHS is a 501(c)(3) organization.

### **Artist Application Process**

#### **Follow These Steps:**

1. Mail Application Form plus \$10 Jury Fee (Jury Fee is waived for returning artists) and applicable Booth Fee based on application date\*. Separate checks for Jury Fee and Booth Fee. Booth Fee will be returned if your art is not accepted.

\*Booth Fees: Now through April 1, 2024 -- \$60; April 2, 2024 through June 1, 2024 -- \$70

Or, pay via Venmo or PayPal (see QR codes on Application). If paying by Venmo/PayPal, the Jury and Booth fees can be made through one transaction. If the Booth fee would need to be returned, it would be done through Venmo/PayPal less the transaction fee.

**2. Mail four (4) photos:** 3 photos <u>per medium</u> that are labeled with Artist's Name and Category and 1 photo of your booth. Returning artists need not submit photos unless there is a change in your media.

Note: Please include a self-addressed envelope with sufficient postage attached if you wish the photos to be returned.

## If you have to cancel:

- Before April 1, 2024, the full amount of the booth fee will be refunded.
- Between April 1, 2024, and May 15, 2024, half of the booth fee will be refunded.
- After May 15, 2024, booth fee will not be refunded (no exceptions.)
